# Keynote Address by Andrew Bridge

Andrew Bridge spent 11 years in Los Angeles County foster care. After aging out, he attended Wesleyan University, then graduated from Harvard Law School and was awarded a Fulbright Fellowship. He began his legal career representing children against the State of Alabama, where his work resulted in the closure of one of the country's most notorious psychiatric institutions, the Eufaula Adolescent Center. Returning to Los Angeles, he became CEO of The Alliance for Children's Rights, representing children in the foster care system where he grew up.

Andrew is the co-founder of National Adoption Day and New Village Girls Academy for pregnant and parenting teens. As Chair of Los Angeles County's Blue Ribbon Task Force, he called for an end to the disproportionate removal of Black babies from their mothers. His memoir <u>Hope's Boy</u> was a New York Times bestseller. His second book about that fight against Alabama, <u>The Child Catcher</u>, released in September, is a National Bestseller and has been nominated for the American Library Association's prestigious Alex Prize, with Kirkus Literary Reviews stating, "Our Verdict. Get It!"

# 40th Anniversary Remarks by Sally Erny

Sally Wilson Erny is Deputy Chief Executive Officer for the National CASA/GAL Association. In this capacity, she leads the Network Development and Stakeholder Engagement teams which include the functions of network program development and support, internal and external communications, judicial engagement, government relations, and resource development. Sally also works with legislative, judicial, executive, and national partners, with a focus on federal appropriations and policy work. During her 26-year career with National

CASA/GAL, Sally has served in a number of roles including Director of Program Development and Chief Program Officer before assuming her current position. Prior to joining National CASA/GAL, Sally served 13 years as Executive Director of CASA of Jefferson County (now CASA of the River Region) in Louisville, Kentucky and earlier served as a Policy Analyst for Kentucky Youth Advocates.

# LEGACY OF SERVICE ALL-STAR

#### Sandra French - CASA of Midwest Kentucky

Sandra has been a CASA volunteer since 2001, serving 25 children over 11 cases in her 23.5 years of service. Most notably, she served a complex case that spanned 10 years before permanency was achieved and was the child's one constant when everyone else changed throughout the case. Sandra's long-term commitment and enduring presence has significantly contributed to CASA's mission.

# **DETERMINED DRIVER ALL-STAR**

#### Linda Halter - CASA of Madison and Clark Counties

Linda has demonstrated unparalleled dedication to visiting with the child on her current case, driving over 17,500 miles total and over 2,100 miles in 2024 alone. Linda visits her CASA child in a residential treatment facility twice per month and continues to advocate for accommodations for the child's mother to be able to travel to the facility for family therapy. Linda has been a consistent presence for this child since appointed in 2021.

# LIMITLESS ENTHUSIAST ALL-STAR

#### **Barb Davis - CASA of Graves County & Southwest KY**

Barb's positivity and enthusiasm is unmatched, and she carries this attitude into her CASA advocacy. She takes on difficult cases and works to ensure that the child's needs are identified and met, and is not afraid to speak up for the child. She can always be counted on to lighten a room, offering humor when it is most needed. Barb also helps with recruiting CASA volunteers and at fundraising events.

# LIFELONG LEARNER ALL-STAR

#### Carol Walker - The Buffalo Trace CASA Program

Carol has completed nearly 300 hours of continuing education since she became a volunteer in April 2015. She averages 32.42 hours per year and so far in 2024, has completed over 16 hours. Carol is always attending and taking advantage of CASA's continuing education trainings. Her dedication to continuous learning and engagement shows her willingness to learn about the challenges faced by children and families on her cases and how she can best support them.

### COMMUNITY CONNECTOR ALL-STAR

#### Vivian Secrest - CASA of South Central KY

Vivian excels at seeking out community resources to ensure the children for whom she advocates have a positive outcome. She once worked on a case in which a language barrier was hindering the reunification of the family. Vivian sought out various community partners to assist in overcoming this barrier and acted as a bridge between the family and the community. In addition to her CASA advocacy, Vivian has played a vital role in recruiting new volunteers in her home county and her efforts led to the largest training group in one of the program's outlying counties.

# **TOUGH CASE NAVIGATOR ALL-STAR**

#### Kacey Clanahan - CASA of West Kentucky

Kacey has been a CASA volunteer for 4 years, advocating for 6 children across 3 cases. Her most recent case, which lasted 2.5 years, was especially challenging due to the mother's severe mental illness. At times, Kacey was concerned about her privacy and her family's safety, leading her to take steps to protect her anonymity in court and online. Despite these difficulties, Kacey remained committed to the children, traveling over 1,000 miles to visit them and dedicating more than 300 hours of service. Her resilience and dedication never wavered, even in the face of such a tough situation.

# **UNSUNG HERO ALL-STAR**

#### Mary Jo Cleves - CASA of the Northern Bluegrass Region

Mary Jo has been a CASA volunteer for 12 years and has had a profound impact on children. Her current case has been ongoing for 7 years, involving 5 children, 10 foster families, and multiple placement changes. Mary Jo has been the children's constant throughout these disruptions. She continues to diligently show up and advocate without seeking recognition or displaying fanfare and her dedication to CASA's mission is unwavering.
