

# 2022 KCN Awards of Excellence

#### **CASA Pioneer Awards**

The CASA Pioneer Award is awarded to individuals who have been instrumental in the development and creation of CASA programs in Kentucky. This award was created in 2019 to recognize board members and/or advisory committee members who went above and beyond to create and nurture the beginning or redevelopment of a CASA program in Kentucky. These are volunteers who contributed significant hours of their time, talent, and expertise to ensure that a solid foundation was in place for sustainability of the Court Appointed Special Advocates program in their community.

### Ruth Lynch | CASA Program of Christian County, KY

Ruth Lynch was part of the first CASA Program of Christian County Board of Directors, serving on the board for the first five years of the program and as board treasurer for the past four years. During periods of staff transition, Ruth stepped up to keep the program solvent by undertaking the general operations of the program. Ruth frequently completed grant reporting and ensured that the program had the needed financial structure in place for program operations. She recruited numerous new board members and worked with community partners to elevate the program's name in the community, including raising awareness for the need for CASA volunteers. ### Carolyn Self | CASA Program of Christian County, KY

Carolyn Self served for four years on the CASA Program of Christian County Board of Directors, and was board chair for two of those years. Carolyn played a significant role in recruiting new board members and provided outreach to stakeholders in the child welfare and court communities to ensure that the program was ready to begin serving abused and neglected children with court-based advocacy. Carolyn helped lead fundraising events and was a staunch ambassador for the program, having recruited some of the program's first CASA volunteers. #### CASA of Graves County & Southwest KY | Carlisle, Fulton, Graves, and Hickman Counties

The program was innovative in developing a three-year strategic plan to assess sustainability, volunteer recruitment and retention, and organizational infrastructure. The program displayed extreme resiliency when they were affected by the 2021 tornado as they worked tirelessly to ensure their volunteers and children were safe, assisted those who had been impacted by the tornado, and showed great flexibility as they searched for a new office building.
